Day-of entry: \$4 per run, or 5 runs for \$15

Closing date for Pre-entries: Monday, July 2, 2018

There will be two rings - Standard and Jumpers. Each ring will have both a Novice and an Excellent level AKC course designed by AKC judge Linda Kipp. A 10-minute walk-through will begin 10 minutes before each start time. Each participant will have 2 minutes in the ring to run the course(s). Food and toys are allowed in the rings, **as long as food is not dropped on the ground or placed on the equipment (If you accidentally drop food, DO NOT LEAVE IT, YOU MUST PICK IT UP)**. Participating dogs must be proficient on the equipment and old enough to trial in the fall.

VOLUNTEER SIGN-UP FORM

Volunteers will earn 1 free run for every 2 hours worked at the fun match, and will be provided with snacks, water, and lunch.

The jobs are listed below. Please indicate which jobs you are willing to do and send this form with your entry form and payment to **Vicki Wilson, 1324 Espejo N.E., Albuquerque, NM 87112**. We will coordinate your working times with your entry times to ensure you have plenty of time to take care of your dog. You will be notified of your working times by email before the fun match.

___ **Gate Steward/Timekeeper.** This person maintains the running order and keeps handlers and dogs moving in and out of the ring efficiently for the designated hour. This person also times each team in the ring.

___ **Ring Steward.** Ring Stewards set the equipment for each jump height, including the jumps, table, A-frame, and tire, and also resets dropped bars between the runs. Each ring needs at least 2 Ring Stewards for each hour.

___ **Leash Runner.** This person moves the leash from the start gate to the finish gate for each team, and also helps the Ring Stewards with setting equipment heights and resetting dropped bars.

___ **Set-up Crew.** We need many helpers to unload the equipment from the truck and set it up on Friday afternoon, the day before the fun match. Time and weather permitting, set-up crew may be able to run their dogs on Friday afternoon.

___ **Take-down Crew.** We need many helpers to load the equipment into the truck at the end of the day on Saturday.
