**Regular Handler Fees (Reg):**

Pre-entry fee: \$5 per run, or 5 runs for \$20  
Day-Of entry fee: \$7 per run, or 5 runs for \$30

**Junior Handler Fees (9-18 years old) (JH):**

Pre-entry fee: \$3 per run, or 5 runs for \$10  
Day-Of entry fee: \$4 per run, or 5 runs for \$15

There will be two rings running at all times, Standard and Jumpers. Each ring will have both a Novice and an Excellent level AKC course designed by AKC judge, Linda Kipp. Each participant will have 2 minutes in the ring. Course walk thrus 10 minutes before each scheduled ring starts. Food or toys are allowed as long as no food is dropped on the course. Participating dogs must be proficient on all the equipment and old enough to trial this fall season. **There will be some NADAC Hoops for the last two time slots for the Jumpers Ring.**

\_\_\_\_ **Courses Set Up Crew:** Persons who help unload the equipment and help set up the rings on Friday at 4:00PM (may be able to run their dog after the rings and courses are setup on Friday).

\_\_\_\_ **Take Down Crew:** Persons who help take down and load the equipment back on the trailer on Saturday.
